### PROPOSED TOILET BLOCK AT RAMPART STREET, GALLE FORT

**Contract No. BRC/NH/F/W/NCB-01 (GHF)**

1. **The Chairman, Ministry Procurement Committee** on behalf of the **Secretary, Ministry of Buddhasasana, Religious and Cultural Affairs (National Heritage Division), 4th Floor, Sethsiripaya - II Stage, Battaramulla** now invites sealed bids from eligible and qualified bidders for “**Proposed Toilet Block at Rampart Street, Galle Fort**” as described below.

The work consists of Concrete works, Masonry Works, Painting Works with Civil works Electrical Works, Plumbing Works etc, as described in Drawings, Specifications & Bill of Quantities.

2. Located at **near the Galle Heritage Office Building at Fort, Galle**. The Construction period is **90 days**. Engineers Estimate is approximately **Rs. 17.4 Million** (excluding VAT)

3. Bidding will be conducted through **National Competitive Bidding procedure**.

4. To be eligible for contract award, the successful bidder shall not have been blacklisted and shall meet the following requirements.

All bidders shall be registered with the Construction Industry Development Authority (CIDA) (Former ICTAD) under the following requirements.

**Specialty : Building Construction**

**Grade : C7 or above**

5. Qualification requirements to qualify for contract award include:

- Average annual value of construction works performed in **last five years** shall be at least **Rs. 26.1 Million**.
- The minimum amount of Liquid Assets and / or credit facilities required is **Rs. 5.0 Million**

6. Bid shall be valid up to 19.12.2025 (77 days from date of closing of the bid.)

A complete set of Bidding Documents in English language may be purchased by interested Bidders on submission of a written application to **Accounts Division of the Galle Heritage Foundation, No.12, Rampart Street, Fort, Galle** until 01.10.2025 from **09.00 hrs to 15.00 hrs** on working days upon payment of a non-refundable fee of **Rupees Three Thousand Five Hundred (Rs.3,500.00)**. The method of payment will be in cash. Please attach the receipt of paying non-refundable fee to the Bid.

9. Pre Bid meeting will be held at the office premises of Galle Heritage Foundation (No. 12, Rampart Street, Fort, Galle) at 10.30 hrs on 24.09.2025.

10. All bids shall be accompanied by an unconditional Bid Security valued **Rs.174,000.00** issued in favor of the **Secretary, Ministry of Buddhasasana, Religious and Cultural Affairs** from commercial bank operating in Sri Lanka valid until 26.01.2026 (105 days from the Bid closing date) **or cash deposit to the Galle Heritage Foundation**.

11. Deadline for submission of bids shall be at 1.30 hrs on 03.10.2025.

12. Duly completed sealed bids in duplicate shall be sent under registered post to receive on or before above closing time to the **Additional Secretary, Ministry of Buddhasasana, Religious and Cultural Affairs (National Heritage Division), 04th Floor, Sethsiripaya - II Stage, Battaramulla** or deposited at the Tender Box No.01 placed at the **Procurement Division of the Ministry of Buddhasasana, Religious and Cultural Affairs (National Heritage Division), 04th Floor, Sethsiripaya - II Stage, Battaramulla** on or before above closing time. Late bids shall be rejected. Name and the Contract Number should be indicated on the left-hand top corner of the envelope.

13. All bids shall be opened immediately after closing of bids at the above address. Bidders or their authorized representatives are requested to be present at the opening of Bids.
